# NOTICE OF MOTION UNDER S 87G OF THE ACT FOR GRANT OF RESOURCE CONSENT

- 1. Far North Solar Farm Limited (Applicant) has applied to South Wairarapa District Council (Council) under s 88 of the Resource Management Act 1991 (Act) for a land use consent to establish and operate a solar farm in the Wairarapa (Consent Reference RM220103) (the Application). The Applicant applies under s 87G of the Act for its Application be determined by the Environment Court instead of the Council.
- 2. The grounds for the Applicant's application under s 87G of the Act are:
  - (a) The Applicant seeks land use consent to establish and operate a 175-megawatt (peak) solar farm at 415 Moroa Road, Greytown, 312 Bidwills Cutting Road, Greytown; 1942 State Highway 2, Greytown and 18 Pharazyns Road, Featherston. The proposal includes:
    - (i) 321,160 photovoltaic solar panels on tracking tables, with a maximum height of 4.5 m above the ground.
    - (ii) 40 inverters and associated electricity infrastructure.
    - (iii) Buildings not required for primary industry or residential purposes exceeding 25m<sup>2</sup>.
    - (iv) Associated site works and site accessways.
    - (v) Screen planting.
  - (b) Resource consent is sought as a discretionary activity (Rule 21.6(a)) and restricted discretionary activity (Rules 4.5.5(c) and 4.5.5(e)(i)) of the Wairarapa Combined District Plan. A 35-year consent duration is sought.

- (c) The Applicant on 9 June 2023 applied to the Council under s 87D of the Act for the Application to be determined by the Environment Court instead of the Council. On 11 September 2023 the Council decided to grant the Applicant's request under s 87E of the Act.
- (d) The Applicant has considered the report prepared by Council under s 87F of the Act dated 6 October 2023 and continues to seek to have its Application determined by the Environment Court.
- (e) There is a significant level of public interest in the Application. 46 submissions were received, of which 5 were partially or fully in support and 41 were opposed. The number and nature of the submissions received indicates that the Application is contentious. Any decision by the Council in the first instance would likely be appealed to the Environment Court.
- (f) It would be more efficient in terms of cost and time for all parties and interested persons for the Application to be heard and determined by the Environment Court instead of Council.
- (g) The Application process would benefit from the comprehensive range of case management tools available to the Environment Court to manage parties' preparation for and participation in a hearing on the Application.
- (h) The further grounds contained in the affidavit of Laila Alkamil dated 12 October 2023.

- 1. You must lodge the original and 1 copy of this notice with the Environment Court. The notice must be signed by you or on your behalf. You must pay the filing fee required by <u>regulation 35 of the Resource Management (Forms, Fees, and Procedure)</u> Regulations 2003.
- 1A. If this is a notice of motion for proceedings under <u>section 87G</u>, <u>198E</u>, or <u>198K</u> of the Resource Management Act 1991, you must lodge this notice with the Environment Court within 15 working days after receiving the report provided under section 87F(5) or 198D(5) of that Act or preparing the report under section 198J(2) of that Act.
- 2. You must serve copies of this notice and the affidavit on the local authority or consent authority, and on any person who made a submission on the matter, as soon as is reasonably practicable after lodging the notice.
- 3. As soon as is reasonably practicable after you have served the documents, you must advise the Registrar of the names, addresses, and dates of service of the persons served.

#### Advice to recipients of copy of notice of motion

How to become a party to proceedings

- 1. You may be heard on this application if you come within section 274(1) of the Resource Management Act 1991. If you are a trade competitor of the applicant, your right to be heard may be limited.
- 2. You may be heard on the application as a party if—
  - (a) within 15 working days after this notice of motion was lodged with the court, you lodge a notice in form 33 with the Environment Court and serve copies of your notice on the relevant local authority and the applicant; and

(b) within 20 working days after this notice of motion was lodged with the court, you serve copies of your notice on all other parties.
