- [1] The Court acknowledges receipt of the memorandum from counsel for the Applicant dated 18 December 2023.
- [2] With respect to the appointment of a Process Advisor/Friend of the Submitters, the South Wairarapa District Council is directed to consult with the Applicant to agree an appropriate candidate and advise the Court and s 274 parties by 5pm on 15 January 2024. The Court will then make that appointment.
- [3] The parties' position on mediation is noted. Mediation will not be scheduled ahead of the evidence exchange timetable however there may be merit in mediation

after expert conferencing and the Court will leave that matter until then.

- [4] The Court grants the request for electronic service of documents and directs:
 - all documents relating to the direct referral process may be filed in electronic form with the Court by email to Jennifer.Gerritsen@justice.govt.nz;
 - all documents relating to the direct referral process may be served in electronic form on all parties by email (using the email addresses recorded in the Court's Parties List and copying in Environment Court Case Manager Jennifer Gerritsen at Jennifer.Gerritsen@justice.govt.nz);
 - as a secondary measure, all documents will be uploaded to the Environment Court website. Parties should note that file sizes are limited to 32MB and upload may not occur contemporaneously with the filing of documents.
- [5] The timetable set out in paragraph 16 is noted. I consider some of the timeframes to be ambitious given the number of unrepresented parties and accordingly make the following timetabling order:
 - (a) the Applicant to file with the Court and serve on all parties its evidence-in-chief by 4pm on Wednesday, 14 February 2024;
 - (b) 15 working days later: The Council to file with the Court and serve on all parties its evidence-in-chief by 4pm on Wednesday, 6 March 2024;
 - (c) 20 working days later: Submitters to file with the Court and serve on all parties their evidence-in-chief by 4pm on Friday 5 April 2024;
 - (d) 10 working days later: All parties to file with the Court and serve on all other Parties any rebuttal evidence by 4pm on Friday, 19 April 2024;
 - (e) 5 working days later: The Applicant is to file four hard copies of all evidence and the common bundle of documents with the Court by 4pm on Monday 29 April 2024.
