**May it please the Court**

- 1 This Memorandum of Counsel is filed on behalf of the Otago Fish and Game Council and the Central South Island Fish and Game Council in response to the Court's direction that Mr Farrell file any supplementary evidence in response to the Joint Witness Statement three working days prior to the resumption of Fish and Game's case.
- 2 Fish and Game appreciate the opportunity for Mr Farrell to file supplementary evidence, however Fish and Game's case is resuming on Thursday 20 May meaning Mr Farrell's evidence is due Monday 17 May.
