I am interested in the following particular issues:

Traffic flow at Kristin School is a major safety concern that affects not only the school but the surrounding community.

Currently there is only 1 access point for approximately 15-20 Kristin buses to enter and exit the school premises through Gate 1. They share this access point with The Little Doves and Junior School families. Middle and Senior School families also use Gate 1 for the drop off zone.

This has put enormous pressure on Albany Highway and Rosedale Road and generates long queues of cars that stops the free flow of traffic. The T2 lane does not alleviate any traffic congestion either. The restriction placed on the traffic movement impacts not only entry/exit access but also safe traffic movement within the school.

Kristin School has tried many different traffic solutions to keep their students and families safe, and while there was some initial improvement, there are factors that are out of the school's control - Auckland's growing population, where a family does not have access to a public transport option, to name a few. It feels like it is an accident waiting to happen when there is a viable option to access Bass Road to offer relief to the congestion traffic issues Kristin School experiences and keep our students safe.

I support the relief sought because of the reasons listed above.

I agree to participate in mediation or other alternative dispute resolution of the proceedings.

- the period for lodging a notice of appeal ends, if the proceedings are an appeal; or
- the decision to hold an inquiry, if the proceedings are an inquiry; or
- the proceedings are commenced, in any other case.

Your right to be a party to the proceedings in the court may be limited by the trade competition provisions in section 274(1) and Part 11A of the Resource Management Act 1991.

The notice must be signed by you or on your behalf.

You must serve a copy of this notice on the relevant local authority and the person who commenced the proceedings within the same 15 working day period and serve copies of this notice on all other parties within 5 working days after that period ends.

However, you may apply to the Environment Court under section 281 of the Resource Management Act 1991 for a waiver of the above timing or service requirements (see form 38).
