1. **Auckland Council** wishes to be joined as a party under section 274 of the RMA in relation to the appeal lodged by Housing New Zealand Corporation under section 157 of the LGATPA against the decision of Auckland International Airport Limited on a designation included in the Auckland Unitary Plan, namely, Designation 1100: Auckland International Airport (**Designation 1100**).
2. **Auckland Council** claims status to be heard on the appeal as the relevant local authority.
3. **Auckland Council** is not a trade competitor for the purposes of sections 308C or 308CA of the RMA.
4. **Auckland Council** is interested in the appeal as it relates to Designation 1100, which provides for the operation of Auckland International Airport, and relates to a rejection in part by the Respondent of the Council's recommendations for Designation 1100.
5. **Auckland Council** supports the relief sought in that it seeks a reinstatement of the Council's recommendations for Designation 1100.
6. **Auckland Council** agrees to participate in mediation or other alternative dispute resolution of the proceedings.
